Upon motion made by Woodrow, seconded by Winder, and unanimously carried, with the following vote: Lloyd-aye, Carlson-aye, Winder-aye, and Woodrow-aye, the Council moved to approve and adopt Resolution No. 2022-03 A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ALBION, IDAHO, AUTHORIZING THE MAYOR TO SIGN ALL APPLICATIONS, FUNDING AGREEMENTS, AND OTHER DOCUMENTS RELATING TO DRINKING WATER PROJECT (HEREINAFTER "PROJECT") as presented.

DISCUSS CURRENT NET METERING POLICY AND ORDINANCES GIVING EFFECT TO THE POLICY

City Attorney Kerry McMurray reported to the Council it would be in the best interest of the City to repeal City Code Title IV, Section 5:1 M and N, and the Net Metering Policy. This allows the City time to research and develop a Policy better suited to work with the City's Electrical System.

The issue was tabled until the October Council Meeting.

City Attorney Kerry McMurray reported he will prepare an Ordinance for Council approval at the October Council Meeting.

PARK SPRINKLER SYSTEM

Mayor Isaac Loveland reported he spoke to Silver Creek, and if the City does not get the Sprinkler System parts from them, we cannot use their Sprinkle System design, which they provided at no cost. The Mayor asked the Council for their opinion. Council President Kevin Lloyd reported he would like to move forward with the Project, as we have discussed this for several years, and if we continue to put it aside, the cost will only increase.

Upon motion made by Carlson, seconded by Lloyd, and unanimously carried, with the following vote: Lloyd-aye, Carlson-aye, Winder-aye, and Woodrow-aye, the Council moved to approve up to twenty-two thousand dollars (\$22,000) for parts for the Park Sprinkler System.

ROAD REPAIRS

Mayor Isaac Loveland reported Kloepfer Concrete & Paving provided a Bid for paving several sections of roads within the City. Included in the Bid was Gamble Dr., South Main St., and the gravel section between Hansen St. and Mountain View Dr. Upon motion made by Lloyd, seconded by Woodrow, and unanimously carried, with the following vote: Lloyd-aye, Carlson-aye, Winder-aye, and Woodrow-aye, the Council moved to approve up to fifty thousand dollars (\$50,000) for road repairs.

INFORMATION FROM CITY OFFICIALS

Councilperson Dallan Doc Carlson asked about the Sidewalk Project, to which Mayor Loveland reported he is meeting with the Engineers this week to discuss the Project. Mayor Loveland reported he signed the CPS Grant Agreement, and sent it to LHTAC. The City is waiting to receive the Grant Funds.

Council President Kevin Lloyd reported he is hoping new Park bathrooms can be built soon.

Mayor Isaac Loveland reported funds are available for the bathrooms, if the cost is not too extreme.

Maintenance Director David Hageman reported he is hoping to get a bid from the contractor that reroofed the pump house.

Mayor Isaac Loveland reported Tree Whisper is in town to trim tree branches away from the power lines. The Mayor reported there may be a power outage because of the tree trimming.
