

**THE CITY OF ALBION, IDAHO
RESOLUTION NO. 2017-02**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE
CITY OF ALBION, IDAHO, SETTING AND INCREASING CITY
PARK RATES FOR CAMPING AND PAVILION USAGE,
EFFECTIVE OCTOBER 1, 2017.**

WHEREAS, the City of Albion has a City Park, that includes an enclosed pavilion; and

WHEREAS, the City allows rental of camping spots and recreational vehicle hookups at the City Park for private purposes; and

WHEREAS, the Mayor and City Council allow rental of the City Pavilion at the City Park for private purposes; and

WHEREAS, it has been determined, through experience, that when alcohol use is part of park or pavilion rental, clean-up is more burdensome on city employees and thereby costs the City more money for maintenance; and

WHEREAS, the Mayor and City Council have determined that it is reasonable and appropriate to raise rates for camper and recreational vehicle use with electrical hookup; increase rates for City Pavilion rental; establish a new fee for City Pavilion or Park use when alcohol use is involved; and to increase the deposit for pavilion rental to cover the costs associated with maintenance of the City Park and the City Pavilion;

WHEREAS, the Mayor and City Council have determined with current rental reservations being in place that such new rates shall take effect on October 1, 2017.


NOW THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Albion that the following uses and rates for City Park and/or City Pavilion be, and hereby are, established, for rentals, hookups and deposits from and after October 1, 2017:

| 4. City Pavilion, Deposit | \$150.00 |


BE IT ALSO RESOLVED by the Mayor and City Council of the City of Albion that said increase shall be in effect from and after October 1, 2017.


