

**THE CITY OF ALBION, IDAHO
RESOLUTION NO. 2015-04**

**A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE
CITY OF ALBION, IDAHO, INCREASING ELECTRICAL
SERVICE RATE BY 2.75% PER KILOWATT, EFFECTIVE
SEPTEMBER 15, 2015.**

WHEREAS, the City of Albion purchases electricity from Bonneville Power Association (hereinafter "BPA"); and

WHEREAS, BPA has notified the City in July of 2015 of an upcoming power purchase increase of up to seven and seventy-five hundredths percent (7.75%) beginning in October, 2015; and

WHEREAS, the Mayor and City Council have reviewed current rates, current city finances, and information from BPA; and


WHEREAS, the Mayor and City Council have determined that it is reasonable and appropriate to raise Customer's electrical service rates, which are currently 8.43¢ per kilowatt, by two and seventy-five hundredths percent (2.75%) to the rate of 8.66¢ per kilowatt, to offset part of the costs to the City for electrical power costs.

NOW THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Albion that the "per kilowatt" rate shall be increased from 8.43¢ per kilowatt to 8.66¢ per kilowatt, said increase being an increase of two and seventy-five hundredths percent (2.75%).

BE IT ALSO RESOLVED by the Mayor and City Council of the City of Albion that said increase shall be in effect from and after September 15, 2015.

The foregoing resolution was passed and approved at a duly noticed public meeting of the Albion City Council, held in compliance with the Open Meeting Law of the State of Idaho on the 1st day of September, 2015, by a vote of 4 in favor and 0 opposed to said resolution. This written resolution memorializes said action, being executed *Nunc Pro Tunc* this 6th day of October, 2015 for the 1st day of September, 2015.
