RESOLUTION NO. 2019-01

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ALBION, IDAHO SETTING WATER BASE RATE FEES AND WATER USAGE RATES FOR THE CITY WATER SYSTEM, IN ACCORDANCE WITH ALBION CITY CODE, WHICH ADOPTED FEES DO NOT EXCEED CURRENT FEES BY FIVE PERCENT OR MORE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Council has reviewed fees related to the usage of city water by those connected to the City Water System; and

WHEREAS, the current monthly base rate water fees in the City of Albion are: for 5/8 inch service \$31.50; for ¾ inch service \$36.57; for 1 inch service \$36.89; for 1 ½ inch service \$43.56; and for 2 inch service \$46.73; and

WHEREAS, the current usage rates are \$0.20 per each 1000 gallons in excess of 25,000 gallons up to 150,000 gallons per month usage; and \$2.40 per 1000 gallons in excess of 150,000 gallons per month usage, with the first 25,000 gallons being covered by the base rate fee; and

WHEREAS, the City has deliberated on this and determined that a flat base rate fee of \$33.00 per month per service for the first 150,000 gallons per month usage, then a usage rate fee of \$1.00 per 1000 gallons in excess of 150,000 gallons per month usage for each service will be necessary to fund the operation, maintenance, updating, replacement and financing of the City's Water System; and

WHEREAS, such fees do not exceed five percent (5%) of any existing fee, in fact in many instances the new fee and rate is a reduction of existing fees and rates, nor is there the institution of any new fees, public notice and public hearing of these fee and rate settings in not required by law; and

WHEREAS, the City Council has determined to adjust the base rate fee and usage rate accordingly by resolution, as allowed by city regulation.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF ALBION, IDAHO THAT:

1. The standard base rate fee for each water service connection shall be Thirty-Three Dollars (\$33.00) per month for the first 150,000 gallons per month usage; and


2. Thereafter the water usage rate fee of \$1.00 per 1000 gallons in excess of 150,000 gallons per month usage will be charged for each service connection.


